The United States Department of Labor's Occupational Safety and Health Administration (OSHA) has partnered with The National Institute for Occupational Safety and Health (NIOSH) and The National Occupational Research Agenda (NORA) in an effort to reduce fall protection in residential construction.

Every year, hundreds of fatalities are reported in the Construction Industry. Many of these fatalities are as a result of construction workers falling from roofs, and from the improper use of ladders and scaffolds. Falls are the leading cause of death in the Construction Industry and can be prevented with proper planning, providing and training.

By following these three simple steps provided by (<u>OSHA.gov</u>, 2010), you can save lives:

- Plan Plan ahead for potential fall hazards. Evaluate the job site, tasks that will be completed, and the equipment used to perform each task. Ensure that all equipment is readily accessible, and proper Personal Protective Equipment (PPE) is provided.
- 2. Provide Provide equipment that workers need to complete tasks, i.e. Ladders, Scaffolds, and Personal Fall Arrest Systems (PFAS). A fall from a lower level; for example, six feet can end in fatality or serious injury.
- Train Workers must be trained in the safe use equipment to complete job tasks. Employers must also train workers to recognize potential hazards and fall protection systems.

OSHA has announced a new National Emphasis Program (NEP) for occupational exposure to isocyanates!

The Occupational Safety and Health Administration (OSHA) announced a National Emphasis Program (NEP) to protect workers from the serious health effects from occupational exposure to isocyanates in 2013. This NEP scheduled to last through 2016, will focus on workplaces in general, construction and maritime industries that use isocyanate compounds in an effort to reduce occupational illnesses and deaths.

Exposure to isocyanates can cause chest tightness, wheezing, coughing, shortness of breath occupational asthma, upper respiratory irritation, hypersensitivity pneumonitis, and skin irritation. Effects from isocyanates may be serious and sometimes fatal.

New bulletin on recording requirements for temporary workers

The Occupational Safety and Health Administration (OSHA) recently announced a new educational tool, now readily accessible at www.osha.gov that will better identify who is responsible for recording injuries and illnesses for temporary workers. The bulletin tool further explains the reporting requirements for staffing agencies and host employers.

"The Recordkeeping Bulletin is the first of many materials we are releasing and helps to clarify which employers are responsible for reporting injuries and illnesses," "These materials will provide valuable information for both host employers and staffing agencies on how they can work together to make sure their workers are properly trained and protected." – Dr. David Michaels, Assistant Secretary of Labor for OSHA

OSHA has received innumerous reports of temporary workers suffering from serious or fatal injuries. OSHA has therefore made a concerted effort to provide enforcement, outreach and training to protect temporary workers, and ensure that they are afforded the same training and education opportunities as existing workers.

Under the OSHA Recordkeeping regulation 29CFR 1904, covered employers are required to prepare and maintain records of serious occupational injuries and illnesses.

Are you safe from the heat?

Heat illness is sweeping the nation, claiming the lives of thousands of outdoor workers. It is imperative to stay hydrated, take breaks and monitor temperature and working conditions.

Beat the heat! Prevent heat illness in outdoor workers by following these three simple steps provided by (OSHA.gov).

- 1. Water
- 2. Rest
- 3. Shade

OSHA's key pieces of advice for workers are:

- Drink water often. Preferably every 15 minutes, even if you are not thirsty
- Rest in the shade to cool down
- Wear a hat and light-colored clothing
- Learn the warning signs of heat illness and what to do should an emergency arise
- Keep an eye on fellow workers

Some symptoms of heat illness may include weakness, wet skin, headache, dizziness, faint, confusion nausea or vomiting, and thirst. Heat illness can affect the workers nervous system and lead to death.

The Occupational Safety and Health Administration (OSHA) and Department of Labor (DOL) have developed a heat safe phone application tool for android and iPhone users. This app allows workers and employers to calculate the heat index, monitor risk levels and provide safety precautions if needed.



Remember, employers are required to provide a safe and healthful workplace, free from recognized hazards.

The Occupational Safety and Health Administration (OSHA) will continue to hold public hearings through Friday, April 4, 2014 for public comments on the proposed silica rule making. OSHA's proposed rule seeks to decrease workers exposure to crystalline silica.

Prolonged exposure to silica can result in health conditions such as silicosis, cancer or kidney disease. Silica affects workers in the construction, general and maritime industries. Overexposure to this substance can be avoided.

Puzzle: Poison



Hydrochloric acid is a corrosive, fuming, poisonous, highly acidic solution of hydrogen chloride (HCI). Sodium hydroxide is a caustic, strongly alkaline compound (NaOH) used in drain cleaners.
